- Students must maintain satisfactory academic progress to continue in the program.
- Your first internship will be evaluated by interviewing your field liaison and agency supervisor to ascertain your compatibility with the culture of DSS.
- Acceptance of this stipend may affect any other financial aid that you receive.
   Be sure to discuss it with a financial aid advisor.
- Once award decisions are made you will be notified in writing. If you choose to
  accept a stipend you are required to sign and have notarized a student contractual
  agreement.
